Subject:- Revision of 1/3rd commuted portion of pension in respect of Government servants who had drawn lump-sum payment on absorption in Central Public Sector Undertaking/Central Autonomous Bodies-Implementation of Government's decision on the recommendation of the Sixth Central Pay commission.

Reference in this regard is invited to para-7 (a) of GOI, Ministry of P, PG & Pensions, Department of Pension & Pensioners' welfare O.M. F.No. 38/37/08- PA&PW (A) dated 1st September,2008 in which it is mentioned that in cases where the Government servant have drawn one time lump sum terminal benefits equal to 100% of their pensions and have become entitled to the restoration of one-third commuted portion of pension as per supreme court judgment dated 15-12-1995, their cases will not be covered under the said O.M. However, it has come to our notice that some of the Pensions Disbursing Authorities are revising the pensions of above mentioned category in terms of para-4.1 and 4.2 of Govt. O.M. dated 01-09-2008. **It is, therefore reiterated that the instructions issued under this office circular No.57 dated 17-09-2008 and circular no.62 dated 12th November,2008 are not applicable for revision of pensions in respect of Govt. servants who had drawn lump-sum payment on absorption and revision in such cases will be carried out by this office by issue of Corr. PPO.**

2. In this context, GOI, Ministry of P, PG & Pensions, Department of pension & Pensioners' welfare vide their O.M. No. 4/38/2008- P & PW (D) dated 15th

September,2008 have issued separate orders for revision of 1/3rd commuted portion of pension of PSU absorbees. **Keeping in view limited number of such PSU absorbees, it has been decided that pensions of such PSU absorbees will be revised by this office suo-moto through corrigendum PPOs without waiting for any application. In order to ensure that the corrigendum PPOs are issued in all affected cases, all PDAs are requested to report to the OI/C- Manual Group of G-1/Civil section of this office any case(s) in respect of which corrigendum PPOs are not received by them by 05th March, 2009 with the following particulars:-**

1. Name of the absorbees.
2. Name of H.O.O. from which retired
3. Date of restoration of 1/3 rd commuted portion of pension
4. Original PPOs No.
5. Subsequent & Current PPOs (a) (b) (c) (d)
6. Full address of PDA with Bank A/C no., if any
