**Subject:** Revision of Service Pension in respect of Havildar granted promotion of Hony Naib Subedar as per 6<sup>th</sup> CPC.

**Reference:** This Office Circular No. 415 dated 22.07.2009.

Consequent upon the issue of GOI, MOD letter No. 1(8)/2008-D (Pen/Policy) dated 12.06.2009, Circular No. 415 dt. 22.07.2009 has been issued alongwith data sheet filling instructions.

2. During the process of audit of revision claim in respect of Havildar granted Hony rank of Nb Subedar it has been observed that claims are preferred on LPC-Cum-Data Sheet No. 202 A/2008 in cases where pension has already been revised as per 6<sup>th</sup> CPC orders. Revision of such types of cases are not feasible to be carried out under computerized system programme meant for 6<sup>th</sup> CPC Revision and the revision of such cases are required to be processed through corrigendum system programme of EDP (M/S) on data sheet No. 202/2009.

3. It is therefore, requested that in cases where pension has not been revised as per 6<sup>th</sup> CPC, the claim in respect of Havildar granted Hony rank of Naib subedar, Data Sheet No. 202 A/2008 (attached with circular No. 400 dt. 05.12.2008) should be used and submit to Gts/RP Section of this office and in cases where pension has already been issued as per 6<sup>th</sup> CPC orders, the revision claim in r/o Havildar granted Hony rank of Nb Subedar should be preferred on Data Sheet 202/2009 (attached with circular No. 414 dt. 07.07.2009) and submit ot EDP (M/S) section of this office.

4. In view of the position brought out above it is requested that LPC cum data sheet No. 202 A/2008 may be submitted to the Grants Revision Pension Section for the fresh revision cases.

Cases already revised may be submitted on LPC cum data sheet No. 202/2009 to the EDP (M) SW.

5. It is also observed that duplicate/triplicate LPC-Cum Data Sheet in respect of additional pension to old age pensioners have been received to this office and as a result duplicate/triplicate corrigendum PPOs have been issued by this office in few cases.

6. It is pertinent to mention that a new system of grant of additional pension has been introduced in the 6<sup>th</sup> CPC and there is no master in existing state to prevent the issuance of duplicate/triplicate PPOs.

7. To avoid issuance of fraudulent/duplicate PPOs, it is requested that LPC-Cum Data Sheet are forwarded to this office after preliminary check with reference to enfacement of Sheet Roll and ensure that duplicate/triplicate LPC-Cum Data Sheet are not forwarded to this office.
