Kindly refer to Para 3 of this office circular No. 421 dated 03.11.2009, which is based on Para 11.4 of GOI, MOD letter No. 17(4)/2008(2)/D (Pen/Policy) dated 12.11.2008. The provisions of revision of enhanced rate of Ordinary Family Pension for 10 years is applicable for those family pensioners who have been granted enhanced rate of Ordinary Family Pension upto 01 Jan 2006, thereafter normal rate of Ordinary Family Pension is admissible w.e.f 02 Jan 2006.

2. In view of above the following amendment is made in this office Circular No. 421 dated 03.11.2009 quoted above.

In Para 3 line 10 For “**02.01.1999**” Read “**01.01.1999**”

3. In view of the position brought out above it is requested that LPC cum data sheet may be submitted to the Officer In charge G 4 Section for the revision of enhanced rate of Family Pension for 10 years in respect of service personnel who died in service on or after 1.1.1999 due to non attributable causes and have been granted Ordinary Family Pension together with a covering list marked as “Revision of Enhanced rate of Family Pension for 10 years.”
