**Subject: -** Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission – Revision of Pension of Pre 2006 Armed Forces Pensioners / Family Pensioners.

Of late it has come to the notice that the PDAs are finding it difficult to revise the pension in respect of Pre 2006 PBOR Naval Pensioners correctly in absence of uniform groups of the Services. It has been observed that PPO of Naval PBOR was issued by the Office of the PCDA (Navy) Mumbai showing their group in numerical instead of Alphabets as enumerated in Para 2 below.

2. Pension Group in respect of Naval PBOR shown in the PPO which had been issued prior to 01.01.2006 is as follows:-

(i) Naval PBOR discharged between 01.01.1996 and 09.10.1997.

In view of the position explained above it is impressed upon all the PDAs that the revision of pension in respect of the Naval PBOR may please be regulated with reference to the group as indicated above read with Appendix A to this Office circular number 397 dated 18.11.2008 and circular No. 403 dated 02.02.2009 to avoid any under payment / overpayments
