**Subject:** Submission of Service Pension Claim for Hav granted Hony Nb-Sub.

**Reference:** This Office Circular No 424 dated 30.11.2009.

It has been observed that individual who has been granted Hav (ACP-1) is financially more beneficial than the same person awarded Hony Nb Sub. Therefore, various Record Office approach this office for issuing of Corr PPO for the rank of Hony Nb Sub to Hav (ACP-1).

However, Hony Nb-Sub is a rank, through which they will get the other equivalent benefits as applicable to JCOs while availing of CSD & ECHS facilities or while equating with other civil counterparts. Therefore, the rank should be mentioned in the corrigendum PPO as Hony Nb Sub without change of any pensionary benefits granted to him the rank of Hav (ACP-1).

In view of the above the EDP centre of this office modified there software. Now if the Column for "Last Rank held" is filled with "5A" then Corr PPO will be printed as Hav (ACP-1) and if Column for "Last Rank held" is filled with "6N" then Corr PPO will be printed as Hon Nb Sub. Therefore you are requested to float Corr data-sheet filling the Column "Last Rank held" accordingly.
