A copy of GOI, Min of Defence, Deptt of Ex-Servicemen Welfare, New-Delhi letter MoD ID No. 1(11)/2009/D(Pen/Pol) dated: 10.08.2011 regarding methodology to be adopted for the payment of additional pension to old pensioners/family pensioners, in cases there is a variation of age/ date of birth between PPO/Office records and any of six documents as enumerated in para 2(ii) of this office Circular no 441 dt: 01.10.2010 is enclosed

The matter was referred to Deptt of pension and Pensioners Welfare and it has been clarified by them that additional documents are to be considered as proof of age only, if neither date of birth nor the age is available in PPO/Office records. In other words if, either date of birth or the age is available in the PPO/office records, no other documents is to be relied upon/considered.

In case there happens to be variation of age/date of birth between PPO/Office records and any of the six documents as enumerated in Para 2(ii) of this office Circular No. 441 dated 01.10.2010 then the age/date of birth which is available in PPO/office record is to be relied upon/considered.

Any request from the pensioner regarding change in date of birth in office record is to be considered in accordance with the Rules in FRs, if necessary DOPT may be consulted. Therefore, such cases may please be referred to concerned record office for further necessary action.

3. As regard para 1(ii) of your ibid letter, it has been clarified by them that change in date of birth in office record may be considered in accordance with Rules in FRs/ FRs. If necessary DOPT may be consulted.
