Consequent to issue of GoI, MoD, Dept. of Ex- Servicemen Welfare letters [No. 4\(110\)/07/D \(Pen/ Legal\) dated 30/09/2009 and even No. dated 08/10/2009](#) (copies enclosed), the following amendments are made in this office circular cited under reference above:

**LINE 5 of PARA 1:-** "and family pension" may be added after words War Injury Pension.

**LINE 6 of PARA 1:-** word “revised w.e.f. 01.01.1996” may be replaced by word “recomputed w.e.f. 01/01/1996 but arrears will be payable w.e.f. 01/10/2001”

**LINE 8 of PARA 1:-** “/ family pension” may be added after words invalid pension.

**LINE 5 of PARA 2:-**

For:- “**within one month** from the date of issue of Government letter i.e. by **14/8/09**”

Read :- **by 15/10/2009**

**LINE 8 of PARA 2:-** The following may be added at the end of paragraph “The family pensioner in receipt of family pension as on 1/10/2001 and those in whose case the family pension accrued after 1/10/2001 are required to apply in the enclosed Annexure IA (copy enclosed) for re-computation of family pension. No interest is payable on arrears of family pension.”
